

# AB 1056 Introduced - Fong

- By Jan 1 2012 CCCCO implement a procedure to facilitate the electronic receipt and transmission of student transcripts by districts.
- CCC Contingent upon receipt of new, one-time state, federal, or philanthropic funding for this purpose, to implement a process for the receipt and transmission of electronic student transcripts by January 1, 2013
- This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.
