Sean sent out a communication to the eTrans listservs prior to break, and again afterwards. The email outlines what is changing and needs to be updated, and that that this update will be required to be in place with the launch of support for Area F (in late June 2022). These emails included a draft data dictionary with these changes. Sean has also reached out to eTrans CA participants to call for participants in user acceptance testing.

3. Update: Rollout of support for Area F

Sean reported that he has received responses from LACCD and several CSU's interested in participating in user acceptance testing; Sean will be reaching back out to eTrans CA members to find additional CCC's interested in participating

Steve Klein asked how we are messaging these changes. Sean replied that he is sending out messages in regular intervals, with reminders scheduled to be sent closer together as we approach the release date. Sean is also setting up a board to monitor participants progress towards implementation. It was also noted that colleges integrated through a transcript vendor will need their vendor to make the necessary

changes. Parchment has been contacted and is aware of the changes to be made, though will need to be contacted by their customers relying on this integration for these changes to be developed and implemented.

It was noted that eTranscript CA colleges receiving data, will also need to make changes to accommodate Area F or their current processes may break.
